The National League of POW/MIA Families, incorporated on May 28, 1970, was formed to obtain the release of all prisoners, the fullest possible accounting for the missing and repatriation of all recoverable remains of those who died serving our nation during the Vietnam War. Without the League, America's POW/MIAs would long ago have been forgotten. The League is proud that our efforts led to today's world-wide mission. We are also proud that our flag is universally and legally recognized as the symbol of America's commitment to account for missing US personnel from past wars.

The League is a nonprofit, tax-exempt 501(c)(3) humanitarian organization, financed by contributions from the families, veterans, and others.
