AMERICANS RECENTLY ACCOUNTED FOR: On January 18th, DPAA released notice that **Col Edgar F. Davis, USAF**, of NC, listed MIA in Laos on 9/17/68, recovered 4/29/15 and ID'd 12/22/17, is now accounted for, the first such announcement since September 11th of last year. At that time, DPAA reported the accounting for **CAPT James. R. Bauder, USN**, of CA, listed as MIA 9/21/66 in North Vietnam, recovered 6/11/17, and ID'd 8-28-17.

The number still missing (POW/MIA) and otherwise unaccounted-for (KIA/BNR) from the Vietnam War is 1,601. Of the 1,601, 90% were lost in Vietnam or in areas of Cambodia or Laos under Vietnam's wartime control: Vietnam-1,253 (VN-458, VS-795); Laos-293; Cambodia-48; PRC territorial waters-7. (Country-specific numbers fluctuate when investigations result in changes to loss locations.)

Since formation in 1970, the League has sought the return of all POWs, the fullest possible accounting for the missing, and repatriation of all recoverable remains. The total accounted for since the end of the Vietnam War in 1973 is **982**. A breakdown by country of these 982 Americans is: Vietnam – 665, Laos – 272, Cambodia – 42, and the PRC – 3. In addition, 63 US personnel were accounted for between 1973 and 1975, the formal end of the Vietnam War, for a grand total of 1,045. These 63 Americans, accounted for by US-only efforts in areas where access was possible, were not due to cooperation by post-war governments in Vietnam, Laos or Cambodia. Combined, a total of 280 have been accounted for from Laos, 720 from Vietnam, 42 from Cambodia and 3 from the PRC.

H. RES. 129 PASSES HOUSE OF REPRESENTATIVES: On February 12th, the US House of Representatives passed this important resolution by a vote of 411 – 0, sending a unified message to the American people – including our Armed Forces serving today and our veterans, as well as foreign nations. Introduced by **Representative Sam Johnson (R-TX)**, a returned POW from the Vietnam War, His strong message on the Floor of the House occurred almost precisely 45 years after he and America's other returned POWs were released from many years of captivity in Vietnam. Passage of this resolution reflects true bipartisan, non-political support for the humanitarian accounting mission.

It is now the US Senate's turn to act. The identical measure was simultaneously introduced in the US Senate by **Senator John S. McCain (R-AZ)** as **S. RES. 61**. Non-partisan, non-political passage by the US Senate would further reinforce our country's support for achieving the fullest possible accounting for those who serve our nation – past, present and future. That needs to happen quickly.

ELKO POW/MIA AWARENESS ASSOCIATION ANNUAL CHILI FEED RESOUNDING SUCCESS: The Elko POW/MIA Awareness Association once again held its annual fundraiser for the League. Held on the Saturday of Presidents Day Weekend each year, the "Chili Feed" brings together a remarkable community of people dedicated to supporting our Armed Forces – active duty, veterans and America's POW/MIAs – our UNRETURNED veterans still missing and unaccounted-for from our nation's past wars and conflicts. The committed, patriotic people of Elko and surrounding communities are truly inspirational and extraordinarily generous in supporting the League, at one time literally saving the League's National Office from being forced to close. Beyond this notable support, Les Brown, Director of the Elko POW/MIA Awareness Association, serves as Northern Nevada League Coordinator and Chairman of the Sergeant-at-Arms Committee for each annual meeting.

LEAGUE DELEGATION RETURNED FROM SOUTHEAST ASIA: A National League of POW/MIA Families Delegation, led by Chairman of the Board/CEO Ms. Ann Mills-Griffiths, traveled to Southeast Asia (Laos, Cambodia, Vietnam, & Thailand) January 11th, and returned January 30th. She was joined once again by the League's Senior Policy Advisor since 1989, Richard Childress, COL, USA (Ret), and, for the first time, MIA daughter Cindy Stonebraker, elected member of the League's Board of Directors. Parallel to the League Delegation, and representing the Special Operations Association (SOA) and Special Forces Association (SFA) was Mike Taylor, LTC, USA/SF (Ret), Vice President of SOA and Chairman of the joint SOA/SFA POW/MIA Committee. Mrs. Elli Childress and Mrs. Laura Taylor accompanied their respective husbands and participated with delegation members in some social events and cultural and other activities.

Both delegations met in each country with US Ambassadors and Embassy officials, Defense Intelligence Agency (DIA) Stony Beach specialists and DPAA Detachment personnel. While in Hanoi, the League Delegation met briefly with **US Secretary of Defense James Mattis** who was in-country for meetings with Vietnam's Prime Minister and Minister of National Defense, as well as other senior Vietnamese officials. The League Delegation also met with senior Lao, Vietnamese and Cambodian officials to discuss concepts to advance the accounting mission. In addition to meeting with US officials, SOA/SFA's Mike Taylor met with American and foreign veterans, some of whom fought as enemies during the war. While in Laos, representatives of both delegations (Stonebraker, M. Taylor and L. Taylor) visited a remote recovery site to thank US and Lao personnel for their often dangerous efforts during Joint Field Activities (JFAs) to account for missing Americans. A comprehensive report will be distributed as soon as possible, but suffice it to say that primary objectives were met and all participants hold the view, that difficult as such missions are, this was well worth the effort.

STONY BEACH TEAM PERMANENT STATUS IN VIETNAM NOT YET CONFIRMED: In early December, the League was informed that the Government of Vietnam had formally given approval for a Defense Intelligence Agency Stony Beach specialist to be permanently assigned to the US Embassy in Hanoi. The information, therefore the announcement, appears to have been in error, or at least premature, though provided as solid and reliable. All should have been able to celebrate the successful result of many, many years of effort, in particular by the League. Strong support was also provided by past US Ambassadors and others posted in Vietnam, including immediate past US Ambassador to Vietnam Ted Osius, but also successive DIA Directors. New US Ambassador to Vietnam Daniel Kritenbrink is now on board and supportive, but Vietnam's approval has not yet been formalized. Despite this temporary delay, the League deeply appreciates the efforts of all who helped form the DIA Stony Beach Team in 1986, continued to support them through years of personnel reductions, and fought off attempts to reassign these irreplaceable specialists. Permanent assignment of a Stony Beach specialist was a high priority of discussions with Vietnamese officials.

Chairman's Comment: The Stony Beach Team is comprised of highly trained specialists, language-capable, culturally familiar investigators who augment DPAA Investigation Teams, as they have done effectively for years despite sporadic, insufficient integration by DPAA and having to rotate on a temporary basis in and out of Vietnam. A favorable decision on permanent presence of Stony Beach by Vietnam's leadership is overdue, but a positive response now is in keeping with current assurances of openness, an end to limits on the numbers of US personnel in-country simultaneously, increasing military-to-military and economic cooperation, and the current political environment. I am confident Vietnam's leadership will act soon to approve permanent change of station (PCS) for DIA's Stony Beach specialist. When that occurs, it will be most welcome, deeply appreciated and will expedite investigations to develop leads by interviewing firsthand witnesses before it is too late. There has long been a permanent Stony Beach specialist in Cambodia, filling the gaps since the former JTF-FA Detachment was pulled out and its responsibilities transferred to Detachment 1 in Bangkok. The Stony Beach specialist is the on-site point-of-contact and an invaluable link to the very high level Cambodia POW/MIA Committee. A few years ago, and after 14+ years of consistent League effort, the Lao Government agreed to permit a Stony Beach specialist to be permanently assigned to the US Embassy in Vientiane. For greatest effectiveness in expanding the pace of interviews and investigations, smaller teams must be able to pursue opportunities as they arise, not limited to the timeframe of in-country DPAA Joint Field Activities (JFAs).

COMMITMENT TO THE LEAGUE: On January 1st each year, it is time to send in your dues, or pay online, whether family or associate member, to continue as an active National League of POW/MIA Families member. It is your decision, but be aware that although the Vietnam War is the most recent and still has US personnel listed actively as Last Known Alive, there is significant pressure from the much larger number of WWII and Korean War families, often through Congress, to devote greater assets and resources to recovery of known dead, including through disinterment of Americans buried as “unknowns” in US cemeteries at home and abroad. There is increasing pressure to disinter these known KIA personnel and establish individual identifications, a worthy objective so long as achieving the fullest possible accounting for missing and unaccounted-for Americans is not adversely impacted.

To prevent pressures from Congress from skewing operational schedules, DPAA must establish criteria that are transparent and logical. Such criteria must include, as a first priority, endangered sites, regardless of the war in which the US personnel were lost, and other critical factors. That means the League must remain strong and viable, as we have been for nearly 50 years. **DO YOUR PART**, and donate to the League, including \$25 for each family (voting) or associate member, and \$25 per year for Veteran Service Organizations (VSOs), such as Posts and Chapters of our national veteran groups. Enlist your local community whether your church or civic group or community organizations. Or, hold fundraisers for the League, remembering that regardless of whether an event is a huge financial success, raising responsible awareness to bring your community into supporting the accounting mission is far more important than the precise amount raised.
